WAIVER & PHOTO RELEASE

In consideration of being permitted to attend and/or participate in events offered by Kidsfishing LLC d/b/a The Kids Fishing Club, the undersigned, on his or her own behalf and on behalf of the minors identified below, acknowledges, appreciates and agrees that:

1. An adult must be present for the entire event and must be responsible for their children.
2. I grant permission to use photographs and video footage taken at an event for use in publications. Publications include but are not limited to news releases, publications and the internet. I waive the right to inspect or approve the finished work and waive the right to royalties or other compensation arising from their use or sale.
3. Fishing can be hazardous and dangerous. Certain fish may have sharp teeth. Fishing hooks are very sharp and are a laceration or entanglement hazard. Casting may result in hooking another participant or another participant hooking you. The shoreline may be slippery and falling into the water and drowning. Alligators, snakes, fire ants and other dangerous wildlife may be present. Lightening, heat exposure and inclement weather are a concern. I assume any and all risk or damage or injury while participating at a Kidsfishing LLC event.
4. I am aware of the risk, hazards and danger of personal injury, disability and/or death as a result of participation in Kidsfishing LLC events. If I believe that something is unsafe I will immediately advise the event director of such conditions and refuse to participate.
5. In consideration for my admission, I hereby release, waive and forever discharge and covenant not to sue the owner/lessor of this premises, Kidsfishing LLC d/b/a The Kids Fishing Club or Kidsfishing.org and its owners, agents, employees, officers, directors, trustees, volunteers and all other persons and entities acting on its behalf, from any and all claims, actions, damages, liability, cost or expense including attorney's fees which are related to or arise out of or in any way connected to my child's participation or use of the premises.

By the execution of this agreement, it is my intention to assume all risk of injury and do hereby surrender and waive any rights to sue or exercise any legal right to seek damages against the owner/lessor of this premises, Kidsfishing LLC d/b/a The Kids Fishing Club or Kidsfishing.org and its owners, agents, employees, officers, directors, trustees, volunteers and all other persons and entities acting on its behalf.
7. I acknowledge that participation in Kidsfishing LLC events is strictly voluntary. I hereby certify that I am over 18 years of age. I have carefully read the foregoing covenant not to sue and acknowledge that I understand and agree to all of the above terms and conditions. Prior to signing this agreement, I have had an opportunity to ask any and all questions. I am aware that by signing this agreement, I assume all risks and waive and release all subsequent rights that I may have and possess.
8. This waiver may not be modified in any way. If any part of this waiver is determined to be invalid by law, all other parts of this waiver shall remain valid and enforceable.
